 have or have maintained any business relations with IMMOFINANZ AG or one of
 its subsidiaries in the past year to an extent of significance for me as a supervisory
 board member.
 - I have not acted as auditor of IMMOFINANZ AG nor have I owned a share in the auditing company or have worked there as an employee.
 - I am not a member of the management board of another company in which a member of the management board of IMMOFINANZ AG is a supervisory board member.
 - I am not a closely related member of the family (i) of a member of the management board or of a management-level staff member of IMMOFINANZ AG or one of its subsidiaries or (ii) of the auditor of IMMOFINANZ AG or a shareholder of the auditing company or of an employee of the auditing firm.

Hence, there are no circumstances which could give reason to cause concerns regarding my independence with respect to my function as supervisory board member of IMMOFINANZ AG.
